There was no company profile.


# 7. PROGRAM:

Josh Varner presented information regarding Hazmat response capabilities, equipment, past calls and responses, and function of the Hazmat vehicle.

Mr. Varner emphasized the necessity of having an effective response force from seven county jurisdictions. It is imperative to identify the hazardous chemicals during an incident. When requesting assistance, the community can contact the On Duty Battalion Chief at 979-764-3700 with the name of the Incident Commander, chemical information, best route, access to 500 gallons of water, and personnel and an ALS ambulance on sight. He also encouraged industries to update their emergency plans.

The Hazmat vehicle can accommodate several functions simultaneously. The concept of this vehicle was brought to the table in 2006 and granted in 2007. A 2015 Spartan Cab was ordered in October 2014. The vehicle was displayed after the meeting so LEPC members could view the functions and equipment.
